- 2. Presentation AACOG Year in Review, Diane Rath.
- 3. Swearing in of 2022 Chair Diane Rath swore in Ryan McGuire, who had not been present during the Annual Planning Retreat.

- 4. Roll Call by Laurin Lee Jimenez, Secretary quorum was established.
- 5. Public Comment Dianne Teran shared about collaboration with VA for a Caregiver Series starting in April, as well as a consortium among University of California San Francisco, National Association of Hispanic Nurses, and Alzheimer's Association to launch a one year campaign to increase Latinx engagement in dementia research.
- 6. Consider and Act Upon Approval of the Minutes for December 10, 2021 and February 11, 2022, Jo Alexander motioned to approve the minutes as written, seconded by Brenda Dever-Armstrong; motion carried.
- 7. Chair's Report Ryan McGuire thanked everyone who was able to attend the planning retreat and worked on goal setting, and looks forward to moving together through the post-pandemic "restart" to have an effective impact in Bexar County.
- 8. Director's Report Jo Ann Tobias-Molina, Director, reported on the following:
  - A. Service Delivery: challenges continue in the areas of homemaker services and personal assistance, as contractors continue to have staffing issues. Congregate meal services continue to increase as more and more locations are reinstating congregate services.
  - B. Area Plan: State planning has indicated the current Area Plan will be extended an additional year.
  - C. Older Americans Month: May is Older Americans Month with the theme "Age My Way".
  - D. Partnership with HEB Pharmacy: Interim Residency Program Director for HEB/UT PGY1 Community Based Pharmacy Residency Program has reached out to forge a partnership in providing opportunities for residents in the San Antonio area looking for opportunities to give presentations to the public, on a variety of topics from fall prevention to medication adherence.

# **2022 MISSION STATEMENT:**

The mission of the Alamo Caregiver Support Coalition is to improve the quality of life for caregivers and care recipients through advocacy, information, support, and access to resources.

# 2022 PRIORITY GOAL:

Increase Community Awareness of the Group through Member Involvement in Community Outreach Events, Presentations and Digital Marketing.

# **TOPICS DISCUSSED:**

AACOG Staff Update: The new service Chore Maintenance is set to begin on April 1, this will be for yard maintenance only. The Caregiver Training offered through Trualta will be renewed for another year. AACOG-AAA has one of the highest acceptance to activation onto the portal rate at 95%. This is due to AACOG-AAA staff person Deborah Mendez and her engagement of the caregivers on a weekly basis. The mail outs for the Older Relative Caregiver Back to School event will begin mid-April. This will be for all 13 counties. If members of the Family Caregiver coalition have resource materials they would like to have included in the mail outs please send to Caregiver Services Coordinator Cyndee Pierce.

Site Host, Brenda Schmachtenberger Executive Director with San Antonio Oasis: Ms. Schmachtenberger explained they are a National Non-profit for individuals 50 and over. They offer mostly educational classes, but also consumer interest, physical activity, and arts and crafts. The majority of staff are volunteers that provide supports like Silver Connect which is a social isolation prevention program. This program allows anyone 50 and over call in and chat with a volunteer that is able to offer

support and resources. There are no membership fees and most classes are offered at a small rate to cover costs.

2022 Goals were further discussed, and it was determined that forming subcommittees may provide the support needed to accomplish them.

The Alamo Caregiver Coalition will participate in 4 educational events throughout the year, one per quarter.

- The Coalition will collaborate an event at the end of the summer or early fall with the Alamo Family Coalition members. This event will focus on caregiver resources and may include a panel discussion of Subject Matter Experts from the Coalition membership.
- First event is set: Low Vision Expo April 2, 2022. Jill Piazzi will gather Coalition member's flyers and brochure to display at the Family Caregiver Coalition table. She will need additional volunteers to assist with the event.
- Through the events a focus on increasing family caregiver to add to the e-Blast sent monthly.

Coalition members will determine at the next meeting if hybrid type meetings are still the best way to conduct the monthly meetings.

Coalition members gave updates on the services they are providing.
