Grant Summary Form (GSF)

- *** This form is Mandatory ***
- Applicants who do not submit a GSF results in an unfavorable review
- Includes questions on your project's goals, budget, etc. which hold criteria that is scored – do not leave a question blank.
- The NextZen Platform opens January 23rd, 2025 An invitation link will be emailed to all workshop participants and will be listed on the AACOG website until the submission deadline date.
- GSFs are due to AACOG by 11:59 p.m. on February 17th,2025 via AACOG's NextZen platform.



CJAC GUIDELINES LINK

For an application to receive favorable review by the AACOG CJAC:

- Agency staff representative must attend at least one AACOG Grant Workshop Dec. 17th, 2024, or January 14th, 2025 – Registration link emailed or could be found on the AACOG website.
- Submit only one agency/department grant application per Funding Stream.
 Opportunity opened December 16th, 2024 & the Deadline to submit and certify in eGrants is: February 13th, 2025, no later than 5:00 PM
- Complete and submit AACOG's Grant Summary Form in NextZen platform.
 Email invite will be sent by CJ Planner January 23rd, 2025 & the Deadline to submit is February 17th, 2025, no later than 11:59 PM
- Attend and Present project at the CJAC Scoring and Prioritization Meeting: Mandatory In-Person Only April 8th, 9th, & 10th, 2025 (AACOG Staff will send an agenda showing your scheduled date and time)

CJAC Guidelines Cont'd...

*** Applicants that DO NOT MEET one of these requirements will receive an unfavorable review but may still be recommended for funding. Applicants that DO NOT MEET two or more requirements WILL receive an UNFAVORABLE REVIEW and WILL NOT be recommended for funding. ***



Purpose

Provide services and assistance directly to victims of crime to speed their recovery and aid them through the criminal justice process.

- Responding to the emotional and physical needs of crime victims;
- Assisting victims in stabilizing their lives after a victimization;
- Assisting victims to understand and participate in the criminal justice system; and
- Providing victims with safety and security.



Purpose

- This solicitation is for programs seeking to provide general victim services to broad categories of victim populations that may include victims of commercial sexual exploitation or trafficking, including emergency and long-term residential (shelter) for children and transition-age youth as well as drop-in centers.
- Information about other related funding opportunities is provided below and the *Funding Opportunities* tab of the eGrants Homepage.
- Specialized Advocacy for Commercially Sexually Exploited Youth, FY2026. Projects to support advocacy services for children and transitioned-aged youth within the CSEY Advocacy Model.
- Texas Model for Care Coordination, FY2026. The purpose of this funding is to support programs to implement the Texas Model for Care Coordination for Commercially Sexually Exploited Youth (CSEY)
- Applying agencies for funds to support a CASA or Children's Advocacy Center program support must apply through Texas CASA, Inc. or CACTx



Available Funding

Funding is authorized for these projects under the following sources:

- Victims of Crime Act of 1984 (VOCA) (34 U.S.C. §20103) VOCA Funds are made available through a Congressional appropriation to the U.S.
 Department of Justice, Office for Victims of Crime.
- State funds are authorized under SB30, Section 2.26 passed during the 88th regular session for Trusteed Programs within the OOG.
- All awards are subject to the availability of appropriated funds and any modifications and or additional requirements that may be imposed by law.



Eligible Organizations

- State agencies
- Public & private non-profit institutions of higher education
- ISD
- Native American tribes
- COGs
- Non-profit corporations including hospitals and faith-based organizations
- Units of Local Government which are defined as a non-statewide governmental body with authority to establish a budget and impose taxes (includes hospital districts). Other local governmental agencies should apply through an associated unit of local government.



Application Process

Applicants must access the PSO's eGrants grant management website at <u>eGrants</u> to register and apply for funding.

- For eligible local and regional projects:
- Applicants must contact their applicable Regional Council of Governments (COG) regarding their application.
- Each of Texas' 24 COGs holds its own application planning workshops, workgroups, and/or subcommittees and facilitates application prioritization for certain programs within it's region.
 Failure to comply with regional requirements imposed by the COG may render an application ineligible.
- 2. State agencies, and other organizations proposing projects with a statewide impact, may submit applications directly to the Governor's Public Safety Office (PSO).
- Applicants are required to submit fully developed and detailed grant budgets at the time of application, PSO will not accept placeholder applications and/or budget line items in lieu of a well written and detailed grant application.
- **VOCA:** Non-Profit applicants are limited to a single application per agency, and all other eligible organizations are limited to one application per unit, district, or division.

Funding Levels

Minimum: \$10,000

OOG Maximum: None

- CJAC Recommended Budget Caps: <u>See AACOG Guidelines</u>
- Match Requirement: 20% of the total project costs for VOCA and will be required for the FY26 grant cycle - that information can be found under the funding levels section in the RFA <u>LINK TO VOCA RFA</u>
- NOTE: Match is 20% of the total project costs for VOCA. That means if a total project was \$100,000, 20% of that amount would have to come from match. (\$80,000 in grant funds, \$20,000 in match for a total of \$100,000).

Alamo Area Council of Governments

VOCA Match Info.

- 20% of the TOTAL project cost can be met through cash or inkind contributions
- Matching funds are considered grant funds and may only be used for eligible, approved budget items
- Matching funds may be acquired during the grant period (Oct. 1st,2025 to Sept. 30th, 2026)
- Donations must be received during the grant period to be eligible as in-kind match
- If you exceed the match requirement and your project is awarded, you will be held to the higher amount.



VOCA Match Info...Cont'd.

 You must provide source(s) of in-kind and cash match on the eGrants budget tab *Source of Match subtab*.

NOTE The PSO's formula accounts for the total project budget (that includes match).



Calculating VOCA Match

2 Step Formula & Three examples

Total request is \$80,000

- Step 1. Determine the Total Project Cost by dividing the Amount of PSO Funds Requested by the % PSO can pay.
 - ***** \$80,000/.80 = \$100,000
- Step 2. Determine the Minimum match REQUIRED by multiplying the total project cost by the % of Match Required
 - * \$100,000 X 20% = \$20,000 Required match

Total request is \$100,000

- Step 1. Determine the Total Project Cost by dividing the Amount of PSO Funds Requested by the % PSO can pay.
 - * \$100,000/.80 = \$125,000
- Step 2. Determine the Minimum match REQUIRED by multiplying the total project cost by the % of Match Required
 - * \$125,000 X 20% = \$25,000 Required match

Calculating VOCA Match Cont'd...

Total request is \$500,000

- Step 1. Determine the Total Project Cost by dividing the Amount of PSO Funds Requested by the % PSO can pay.
 - * \$100,000/.80 = \$625,000
- Step 2. Determine the Minimum match REQUIRED by multiplying the total project cost by the % of Match Required
 - * \$625,000 X 20% = \$125,000 Required match

Don't confuse the percentage calculation within eGrants as an error. The PSO's formula accounts for the TOTAL PROJECT BUDGET – this is the formula they use, and it is 20% of the TOTAL BUDGET.

Note 1: Applicants seeking to apply for one of the following CSEY activities should select the Funding Opportunity titled "Victim Assistance, Residential and Community-Based Services for Commercially Sexually Exploited Youth" in eGrants. These applications will be scored and prioritized by the Regional Councils of Governments (COGs) as part of the General Victim Assistance program. Please be sure to contact your local COG for information on local COG policies, eligibility requirements, and deadlines for Fiscal Year 2026 General Victim Assistance funding. Failure to abide by COG policies may render your application ineligible.

Note 2: related to hospital accompaniment with sexual assault survivors: In accordance with Art. 56A.351, Texas Code of Criminal Procedure, a victim shall be offered the opportunity to have a sexual assault program advocate available during a sexual assault forensic exam. Sec. 420.051, Texas Government Code defines a sexual assault program advocate as an individual who has completed a sexual assault training program certified by the attorney general and is an employee or volunteer of a sexual assault program.

Prohibitions

Grant funds may not be used to support the unallowable costs listed in the Guide to Grants or any unallowable costs listed in the Prohibitions list on the Funding Opportunity (RFA).



General Standards

Grantees must comply with:

- Texas Grant Management Standards (TxGMS)
- Federal Uniform Grant Guidance
- All statutes, requirements, and guidelines applicable to their funding stream



Eligibility Requirements

- Local units of governments Cybersecurity Training requirements
- In a county with 90% average or above on dispositions
- Report at least 90% of convictions within 5 business days
- LE- Current on reporting UCR (Uniform Crime Reporting) data and TX specific reporting to DPS (Case Disposition for Adult and Juvenile)
- Comply with the programs and procedures utilized by DHS (Dept. of Homeland Security)



Eligibility Requirements

- Must have a SAM number assigned to agency
- Registered in the federal SAM database
- Link to obtain a DUNS Number
- Link to obtain SAM number

Failure to comply may cause funds to be withheld and/or suspension or termination of grant funds.



Eligibility Requirements Cont'd.

Units of local government and colleges/universities with law enforcement agencies:

- Download, complete, and upload into eGrants the CEO/Law Enforcement Certifications and Assurances Form
- See RFAs



Eligibility Requirements

501(c)(3) organizations:

- Download, complete, and upload into eGrants the CEO/NGO Certifications and Assurances Form
- See RFA for VOCA



Program-Specific Requirements

Program-Specific Requirements are outlined in each funding stream's RFA:

- VOCA Cultural competency, victim services assessment survey, special requirements for vehicle purchases
- VAWA Legal Assistance for Victims (LAV) Certification,




Eligible Activities and Costs

- Each RFA details the funding specific eligible activities and costs
- Each RFA also details prohibited activities and costs



GVA now includes CSEY – Residential and Community Based Services – Select the funding opportunity within GVA you wish to apply for. If applying for both – apps will compete at the regional level.



NOTE on VOCA Funding Opportunity and CJAC Process Changes:

- New this year The CJAC will be conducting a review of all the applications submitted under this funding opportunity
- This review will determine if agencies and organizations applying under this funding stream are Victim Focused or Victim Serving.
- Those determined by the CJAC to be Victim Focused will be given an additional 5 points on their prioritization score.
- Concerns or questions on this can be directed to the AACOG Staff by email prior to the day of scoring.



Juvenile Justice and Delinquency Prevention & Truancy Prevention

Juvenile Justice and Truancy Prevention

- Listed One Funding Opportunity
- All state funding (Coded as SF in eGrants)
- JJDP Non-Profit Organizations and some ISD's depending on their activities
- Truancy Prevention ISDs, Prosecution and Courts, and Government Agencies
- Anyone applying under this funding stream will submit application under a code in eGrants of SF



Juvenile Justice and Truancy Prevention Con't...

- The Governor's Public Safety Office (PSO) reviews applications after deadline to determine if activities are JJDP or Truancy Prevention – AACOG does not determine this.
- PSO then batches two files to us one for applicants that fit JJDP criteria and one for applicants that fit Truancy Prevention criteria.
 Your application remains under this file for the duration.
- March 2025 the PSO sends AACOG two RBE's one for JJDP and one for TP.
- AACOG CJAC then scores the applications within the two categories
- Keep budget caps in mind that are listed on the CJAC Grant Application Guidelines

Justice Assistance Grant (JAG) - Radio Projects

AACOG P25 Multiband Radio & Features Reference Guide

Criminal Justice Strategic Plan


Criminal Justice Strategic Plan

- Available on AACOG Website <u>here</u>
- Outlines regional priorities, which are used as scoring elements during CJAC application scoring and prioritization
- Identifies gaps in services across the region
- Reviewed/revised every few years to ensure that the region's priorities change with local trends and demographic shifts.

Regional Strategic Priorities

- Applications should address one or more Regional Strategic Priorities identified by the community
- Applicants will identify the priorities they address in the Grant Summary Form
- Priorities are available on the AACOG website, in the Criminal Justice Strategic Plan (pg. 4)





Criminal Justice Advisory Committee (CJAC)

Criminal Justice Advisory Committee (CJAC)

- 37 Members (13 from Bexar County and 2 from each rural county)
- Establishes grant application guidelines
- Reviews and evaluates grant applications
- Makes funding recommendations to the AACOG Board of Directors for approval

CJAC Bylaws

- This is the Governing document for the Criminal Justice Advisory Committee
- Reviewed annually; all changes approved by AACOG Board of Directors
- Available on the AACOG Website under Public Safety





Application Review Process

Scoring Meetings

- Will be entirely in-person
- All grant programs present during their allotted time TBD by AACOG staff based on number of applicants per funding stream – you will be contacted with an agenda showing the date and time of your presentation. Can also be found online.
- Applicants will receive a schedule with their timeslot; please arrive 45 minutes
 to an hour before your presentation time in case we are running ahead of
 schedule, or an applicant does not show to present their project
- Applicants will receive unfavorable review if absent
- As with Grant Workshop, a representative from the applying agency must be present – contract grant writers cannot represent the agency alone



Applicant Presentations

- Presentations may be no more than 3 minutes
- An agency staff representative must present the project proposal presentation on the day of scoring.
- *A contracted grant writer may not present on behalf of the agency applying for grant funds*
- If your project is a combined effort in the community via interlocal agreement <u>– the applying agency on record</u> is required to present the project proposal
- No visual aids allowed
- You are Encouraged to include multiple employees for Q&A

- Collaboration (GSF)
- Regional Priorities (GSF)

- JAG Equipment Only: Requests limited to single project and/or package of related items



Grant Review Process


- CJD batches eligible applications to AACOG; COG Staff will assign NextZen GSF submissions to CJAC members while identifying conflicts of interest
- CJAC scores applications and determines recommended funding amounts
- AACOG BOD reviews and approves ranks
- AACOG provides CJD approved priority listings
- CJD reviews and determines final funding decisions



Ranking Meeting Process

- 1. CJAC members review grants and score each application as presented
- 2. Staff formats the scores and provides final scores to CJAC
- CJAC reviews and approves prioritization and makes final decision based on reasonable budget expectations and other factors
- 4. AACOG Board of Directors will review, approve and it will then be sent to the Governor's Office





Application Budget Reductions

Reasonable Budget Expectations (RBEs)

- AACOG Staff will receive RBEs in March 2025
- VOCA funding is anticipated to receive a 20% decrease for the upcoming fiscal year however, the OOG is requesting more federal dollars to cover any decrease.
- OOG may override regional prioritizations and funding recommendations based on programmatic requirements at the state and federal level

Recommended Budget Caps

- JAG: \$75,000 maximum request from OOG; Non-profits \$50,000 maximum request from OOG
- **JJDP**: \$50,000 from OOG
- <u>Truancy Prevention</u>: \$350,000 voluntary maximum request from OOG for all program requests, Continuation projects exceeding last years
 <u>AWARD</u> by 20% must provide justification at your presentation.
- VAWA: \$150,000 maximum request from OOG
- <u>VOCA</u>: \$250,000 voluntary maximum request for new program requests; Continuation projects may exceed last year's award by 20% if all funds were expended the previous grant year. (Eligibility for a 20% increase requires applying agency to have completed expending full year's award by September 30, 2024).

Budget Reductions

- The CJAC reserves the right to recommend a reduced budget for any project.
- The CJAC will determine decreases on the day of grant presentations to holistically gauge all grant applicants for each funding stream based on presentations, grant summary forms, RBE, and amount applied for in each funding stream.

New Projects

New projects must follow all eligibility requirements to qualify as a new project as established by the Office of the Governor.




Continuation Projects

- Applicants will be asked to self-identify their projects as continuation projects on their GSF; eGrants will indicate whether a project is a continuation.
- CJAC will determine decreases on the day of grant presentations to holistically gauge all grant applicants for each funding stream based on presentations, grant summary forms, RBE, and amount applied for in each stream.


Review Summary

- CJAC reviews for quality and ranks by guidelines & priorities identified in the strategic plan
- CJAC may recommend reduced funding
- Failure to comply with regional requirements imposed by the COG/CJAC may render an application ineligible, unfavorable, or recommended with a reduced budget

- New Projects and Renewal Projects to be scored: In addition to eGrants must submit applicable AACOG Grant Summary Forms by February 17th, 2025, by 11:59pm CST via the NextZen Portal Platform – Link to access will be emailed to grant workshop attendees January 23rd, 2025.
