## **PART 1.0 – SCOPE OF REQUEST**

### **1.1 PURPOSE OF REQUEST FOR APPLICATION (RFA)**

#### **Introduction**

The Alamo Area Council of Governments (AACOG) is soliciting Applications from qualified contractors to provide energy conservation and accessibility renovation services within the applicable service area for the Amy Young, Homes for Texas Heroes, and Weatherization programs administered by the Alamo Area Council of Governments (AACOG). Work will be performed in single-family and multi-family units for the AACOG Weatherization Assistance Program (WAP) commencing May 1, 2025 and ending December 31, 2025 contingent upon AACOG approval, and funding availability. AACOG accepts applications for qualifications from firms to provide the following services:

- A. Provide low-income, eligible clients with energy-efficiency retrofit services
- B. Provide home accessibility modifications for people with disabilities.
- C. Provide home modifications and/or home repairs for Veterans.

### **1.2 BACKGROUND INFORMATION**

#### **1.2.1 Alamo Area Council of Governments (AACOG)**

AACOG is a voluntary association of municipal and county governments, and special districts located in Bexar County and the surrounding thirteen counties. Established in 1967 under Chapter 391 of the Local Government Code of Texas, AACOG operates as a political subdivision of the state. It serves its members by facilitating planning, information dissemination, and coordination activities. AACOG covers the Alamo Area/State Planning Region 18, encompassing 13 counties and spanning 12,582 square miles. The counties within the planning region are Atascosa, Bandera, Bexar, Comal, Frio, Gillespie, Guadalupe, Karnes, Kendall, Kerr, Medina, McMullen, and Wilson. Veteran Directed Care program covers a total of 21 counties that are covered by the South Texas Veterans Healthcare System (Audie L. Murphy Memorial Veterans Hospital and Kerrville VA Hospital), including those listed above and Bee, Blanco, Kinney, Hays, Real, Travis, Uvalde, and Val Verde counties.

- 1.2.2** It is AACOG's policy to treat all persons, potential members, vendors, contractors, subcontractors, providers, suppliers, and others fairly, equitably, and non-discriminatorily. AACOG employees, as public servants, will execute their duties in a fair and legal manner, avoiding actual or perceived conflicts of interest.

#### **1.2.3 Funding Sources**

Funding for this RFA is from the United States Department of Energy (DOE) Weatherization Assistance Program (WAP), the Texas Department of Housing and Community Affairs (TDHCA) Low Income Home Energy Assistance Program (LIHEAP), Amy Young Barrier Removal (AYBR) Program, Texas Veteran's Commission (TVC), and Texas Department of Health and Human Services (HHSC). AACOG expects to award multiple contracts for services in the AACOG region.



## **1.3 SCOPE OF WORK**

### **1.3.1 Weatherization Assistance Program (WAP) Work Description**

WAP work includes, but is not limited to the installation of attic, wall, and floor insulation; replacement and/or repair Heating, Venting, and Air Conditioning (HVAC) systems, including central systems and duct work; central and vented wall furnaces, removal of unvented space heaters; venting items to code; removal and replacement of window A/C units; replacement of refrigerators; gas stoves and water heaters; replacement and/or repair of windows, doors or storm windows; installation of solar screens; weather-stripping, caulking, and other air infiltration reduction measures. Other items may include tub surround work, door adjustments, jamb-ups, minor roof repairs, sheetrock work, installation of gas and electrical lines, digital thermostats, smoke and carbon monoxide (CO) detector installation etc.

### **1.3.2 Amy Young Barrier Removal (AYBR) and Homes for Texas Heroes (H4TH) Bid Process**

The Amy Young Barrier Removal (AYBR) program allows for home modifications that increase accessibility, eliminate life-threatening hazards and correct unsafe conditions for eligible homes. Modifications include, but are not limited to ramps, grab bars, door widening, and bathroom modifications. AACOG qualifies family and home eligibility. A third-party vendor and/or AACOG conducts energy audits. AACOG issues a Scope of Work (SOW) to the contractor and a Prebid meeting is held at the project site. Contractors are required to attend the Prebid meeting. The Contractor utilizes the SOW and Prebid meeting to create the bid Application and submit to AACOG. AACOG selects and awards the winning bid to the contractor. The AYBR and H4TH Programs General Work Specifications **EXHIBIT C**. The AYBR and H4TH Material Installation Standards web link is in Section 1.4.20, (42) (43) of this RFA.

### **1.3.3 WAP Bid Process**

AACOG qualifies family and home eligibility. A third-party vendor and/or AACOG conducts energy audits. AACOG defines, creates, and assigns the work order to a contractor. Costs are determined by AACOG.

### **1.3.4 Work Assessment**

AACOG will perform the majority of work associated with assessing homes to determine eligibility for WAP programs. See Exhibit D Assessment Pricing List. Occasionally, AACOG will use third-party contractors to assess home eligibility to expedite the process. Assessment includes blower door testing, duct testing, refrigerator metering, combustion appliance zone testing, plus mandatory camera photographs of walls and anomalies, recommended measures in conformity with LIHEAP Priority list, client questionnaire, floor plan with windows and door sizes, attic inspection, wall inspection, Combustion Appliance Zone (CAZ) zone test, appliance specifications sheet, blower door datasheet, American Society of Heating, Refrigeration, and Air Conditioning Engineers (ASHRAE) 62.2 2016 calculator, duct blower data sheet, refrigerator calculator, refrigerator replacement form, acknowledgement of burglar bar removal, window unit replacement calculator, acknowledgment of refusal of weatherization work measures (if applicable), notes to the auditor, Energy Conservation Education, Unified Weatherization Elements Notification, Mold-Like Substance Notification and Release Form, and Systematic Alien form.

### **1.3.5 All work must comply with all applicable policies, procedures, and regulations of federal, state, and AACOG documents attached and/or referenced in this RFA for the Amy Young,**



Homes for Texas Heroes, and Weatherization programs managed by AACOG. Contractor understands and agrees that any work performed under this RFA is done pursuant to either a State or Federally funded program with detailed specifications and requirements that **MUST** be strictly adhered to and faithfully followed in all respects. Contractor must use only materials which meet or exceed the standards prescribed by referenced or attached documents to this RFA.

- 1.3.6** A "Notice to Proceed" shall be generated to the Contractor that has been awarded the project. The notice to proceed will contain a start date and an anticipated completion date (As dictated by the Program Manager and/or assigned representative in writing). The Notice to Proceed is the official written authorization indicating that a Contractor has been awarded the project. Contractor shall not begin any work until receiving AACOG's written Notice to Proceed.

**1.3.7 Project Budget**

Maximum anticipated funds, per AACOG approval, available per project:

- A. **WAP** funded customers – \$12,000.00 budget per project
- B. **AYBR** funded customers – \$20,000.00 budget per project
- C. **H4TXH** funded customers – \$20,000.00 budget per project

**1.4 General Work Requirements:**

The contractor must recognize the special needs and concerns of low-income, elderly and handicapped clients and must ensure that clients are at all times treated respectfully and professionally. The contractor's staff must conduct themselves in a professional manner at all times.

- 1.4.1** The contractor must be licensed, certified and prepared to adhere to Lead Safety Practices when performing work on older housing stock. Contractors should expect unannounced monitoring of records and work sites by AACOG staff as well as various agencies from the U.S. Government and the State of Texas. All work will be inspected by an AACOG Inspection Professional prior to invoicing.
- 1.4.2** Upon completion of a project, the contractor must remove all debris from the job site and dispose of it in a proper and responsible manner.
- 1.4.3** The contractor will take all precautions necessary to protect all existing trees, shrubbery, plants, sidewalks, buildings, vehicles, etc., in the work area.
- 1.4.4** The contractor is responsible for adhering to the Lead Safe Weatherization. Practices as outlined in the Lead Safe Weatherization Jobsite Handbook by Montana State University Extension Service.
- 1.4.5** The work must be completed in a timely and expeditious manner. The contractor is expected to provide monthly progress reports to AACOG indicating work schedule and work status. AACOG will provide the contractor with an energy audit or listing of all the work measures authorized to be performed by the contractor on the particular dwelling unit. The contractor (work crew supervisor) is responsible for advising AACOG of any recommended changes; however, no changes will be authorized or paid for by AACOG without AACOG's prior written approval. Failure of the contractor to perform the work in accordance with the energy audit or instructions provided by AACOG will be grounds for termination of the weatherization contract.
- 1.4.6** The contractor and its subcontractors are considered independent contractors and shall indemnify and hold harmless AACOG, AACOG Weatherization staff and weatherization clients from all claims arising out of work performed.
- 1.4.7** The contractor must furnish all labor and on-site supervision pursuant to completion of



weatherization activities within the identified AACOG service area.

- 1.4.8** Contractor must rebuild, repair, restore and make good at his/her own expense all injury and damage to same which may result from work being performed under this contract.
- 1.4.9** The contractor's field staff or assigned work crew must be proficient and trained in the proper installation of comprehensive weatherization measures and use and application of weatherization diagnostic equipment and tools. Contractor must complete **Tools and Equipment List Form (Exhibit B)**.
- 1.4.10** The weatherization work measures may include work requiring the professional expertise or skills of a licensed HVAC company, plumber or electrician. The contractor is responsible for ensuring that this be provided. If the contractor chooses to subcontract this type of work, prior written approval from AACOG is required. Subcontractors are subject to the same standards as the general contractor. Therefore, financial capacity, compliance applicable laws, rules and regulations, installation standards, etc., will be required of subcontractors as well. Contractor is responsible for the payment and management of any subcontractors they employ. AACOG will not be charged separately for any type of subcontractors cost or required equipment necessary to perform construction or tests.
- 1.4.11** Contractor is responsible for any job-related illness or injury to workers in their employment and/or weatherization clients and shall indemnify and hold harmless AACOG personnel and weatherization clients in the event an on-the-job illness or injury occurs.
- 1.4.12** **41 CFR Parts 60-1, 60-2, 60-3, 60-4, 60-20, and 60-50 outline the obligations of federal contractors and subcontractors related to equal employment opportunity.** These regulations prohibit discrimination against qualified individuals based on their status as protected veterans or individuals with disabilities and prohibit discrimination against all individuals based on their race, color, religion, sex, or national origin. Moreover, these regulations require that covered prime contractors and subcontractors take affirmative action to employ and advance in employment qualified protected veterans, qualified individuals with disabilities and all individuals without regard to race, color, religion, sex, or national origin.

#### **1.4.13 MATERIAL REQUIREMENTS**

AACOG will not be billed for materials transportation or delivery costs. Materials must be new and in good condition. AACOG will not be charged for items, which are damaged prior to or during installation, or wasted or unused (excess/leftover) materials.

- 1.4.13.1** All materials furnished by contractor must meet applicable U.S. Department of Energy (DOE) standards and must comply with the Texas Department of Housing & Community Affairs (TDHCA) materials standards set forth in the (SWS) Standard Work Specifications, and **(Appendix A)**. Materials must be new and in good condition. AACOG will pay only for those materials which meet applicable standards and which are acceptably and properly installed on eligible dwelling units.
- 1.4.13.2** Contractors are responsible for documenting standards for the installation of materials pursuant to the federal Weatherization Assistance Program. Documentation must be complete and legible and will include photographs of all ECM's installed, documenting serial numbers, model numbers, efficiency ratings and other specifications.





#### **1.4.14 REQUIRED TESTING**

The contractor is required to conduct blower door tests prior to, during, and after the work (air sealing) has been completed. The air exchange rate must satisfy the desired range as prescribed by AACOG. The contractor must also conduct a carbon monoxide test on all combustion appliances in each dwelling.

**1.4.14.1** When ambient CO levels exceeding 9 ppm (parts per million) are detected the contractor will disregard all air-sealing requirements and notify AACOG prior to initiating weatherization activities. Should active knob-and-tube wiring be discovered during the pre-installation assessment, the contractor must immediately contact AACOG prior to the installation of any weatherization measures.

#### **1.4.15 QUALITY REQUIREMENTS**

The contractor must rebuild, repair, restore and make good at his/her own expense all injury and damage to same which may result from work being performed under this contract.

**1.4.15.1** The contractor must own an acceptable refrigerant recovery unit and must dispose of any recaptured refrigerant as required by local code and/or state law.

#### **1.4.16 INSPECTION and REPORT REQUIREMENTS**

The contractor is responsible for correcting any work deficiencies identified by the AACOG Inspection Professional. Deficiencies may include quality of workmanship, size of HVAC systems, incomplete work, etc. Failure to take required corrective action within a reasonable time period (5-7 working days) may result in termination of the contract. The contractor is also responsible to guarantee his/her work. Therefore, any calls from clients regarding problems with installed materials, equipment or appliances are required to be under a one-year warranty by the contractor. Any problems of this nature will require the contractor to return to the dwelling unit for corrective action at no cost to AACOG or the client. Uncorrected penalties will be deducted from monthly pay applications.

##### **1.4.16.1 Building Weatherization Report**

The contractor will submit a Building Weatherization Report (BWR) only for those units fully completed and ready for AACOG's Final Inspection. Following passing the Final Inspection, the contractor will be contacted and directed to submit the invoice(s) to AACOG in a regular and timely manner for payment. The contractor must designate a financial/administrative point of contact for accounting purposes.

##### **1.4.16.2 Amy Young and Homes for Texas Hero Program Penalties**

The undersigned Contractor understands and agrees that time is of the essence in the performance of the work the Contractor has been engaged to perform. The contractor further agrees that a penalty of Forty Dollars (\$40.00) per day shall be held for each and every day the contracted work remains unfinished beyond the agreed-upon completion date for said work. Delays caused by rain or other inclement weather that prevent the performance of the contract, delays caused by circumstances beyond the control of the Contractor, such as shipping delays and material shortages, and/or instances of Force Majeure shall not be penalized. It is the Contractor's responsibility to document these delays and submit this documentation to the appointed Program representative. The contractor



agrees to guarantee all work for a minimum period of one year from the original completion date. The contractor shall, within (5) business days of notification, correct any valid discrepancies or exceptions identified either by AACOG or any of its funding sources or monitoring agencies, i.e., the U.S. Department of Energy (DOE), the U.S. Department of Housing & Urban Development (HUD), State Energy Conservation Office (SECO), TDHCA, the U.S. Environmental Protection Agency (EPA), the Texas Veterans Commission (TVC), the U.S. Department of Labor (DOL), etc. Uncorrected penalties will be deducted from monthly pay applications.

#### **1.4.16.3 Weatherization Program Penalties**

The contractor is responsible for correcting any work deficiencies identified by the AACOG Quality Control Inspector. Deficiencies may include quality of workmanship, size of HVAC systems, incomplete work, etc. Failure to take required corrective action within five (5) working days may result in termination of the contract. The contractor is also responsible for guaranteeing all work performed. Therefore, any calls from clients regarding problems with installed materials, equipment, or appliances are required to be under a one-year warranty by the Contractor. Any problems of this nature will require the contractor to return to the dwelling unit for corrective action at no cost to AACOG or the client. A one hundred dollar (\$100.00) first instance inspection fee shall be paid by the Contractor to AACOG to conduct an inspection of the corrective action. A two hundred fifty (\$250.00) re-inspection fee will be assessed should AACOG need to conduct a second Inspection of the dwelling unit as a result of contractor deficiencies. Thereafter, a two hundred fifty (\$250.00) fee will be assessed to the contractor for each subsequent re-inspection that AACOG is required to conduct in order to obtain a passing Final Inspection. Uncorrected penalties will be deducted from monthly pay applications.

#### **1.4.17 Build America Buy American (BABA)**

For work performed under the WAP program, the Infrastructure Investment and Jobs Act (Public Law 117-58), also referred to as the Bipartisan Infrastructure Law (BIL), provides funding for the Department of Energy's (DOE) Weatherization Assistance Program (WAP). BIL established a domestic content procurement preference for all federal financial assistance obligated for infrastructure projects after May 14, 2022, known as Build America, Buy America (BABA). *BABA applies to BIL-DOE AND regular DOE formula grant contracts (EX: PY23).*

**1.4.17.1 Only weatherization on public housing, or on privately owned buildings that serve a public function are required to comply with the BABA requirements.**

**1.4.17.2** Public housing" means currently owned by a public entity (government—county, city, state, etc.; PHA; HOME; USDA; etc.); it does NOT mean publicly supported (EX: tax credit). Tax records and single audit information can be used to confirm ownership.

**1.4.17.3** Additional guidance received regarding "privately owned buildings that serve a public function":

**1.4.17.4** *Common multifamily complex situations:* privately owned; duplex or four-plex, or two- or three-story buildings with 5- 30 units per building; rent is covered



per individual unit by the individual households; no common space to be weatherized – *BABA does NOT apply.*

#### **1.4.18 Davis-Bacon Act (DBA)**

##### **APPLICATION OF WAGE RATE REQUIREMENTS TO WEATHERIZATION ASSISTANCE PROGRAM**

For work performed under the weatherization assistance program established under part A of title IV of the Energy Conservation and Production Act (42 U.S.C. 6861 et seq.) on a project assisted in whole or in part by funding made available under subsection (a), the requirements of section 41101 shall apply only to work performed on multifamily buildings with no fewer than 5 units. Accordingly, per part (b) above, any BIL-funded weatherization work on multifamily buildings with no fewer than 5 units will be required to pay wages to all laborers and mechanics engaged in the construction, alteration, or repair of those multifamily buildings (whether employed by a contractor or subcontractor) wages “at rates not less than those prevailing on similar projects in the locality, as determined by the Secretary of Labor.” Current Wage Determinations are accessible at [Wage Determinations | SAM.gov](#)

#### **1.4.19 SERVICE AREA**

The Service Area, by funding, for this RFA includes Kerr, Gillespie, Comal, Bandera, Medina, Bexar, Wilson, Atascosa, Karnes, Wilson, Frio, McMullen, and Guadalupe counties.

## **1.5 CONTRACTOR REQUIREMENTS**

- 1.5.1** The Contractor will be required to complete an AACOG Vendor.
- 1.5.2** The Contractor must ensure that clients are at all times treated respectfully and professionally. The Contractor's staff must conduct themselves in a professional manner at all times.
- 1.5.3.** Contractors must be licensed, certified and prepared to adhere to agency rules when performing work.
- 1.5.4** The work must be completed in a timely and expeditious manner. The Contractor is expected to provide bi-weekly progress reports to AACOG indicating work schedule and work status.
- 1.5.5** The Contractor and its subcontractors are considered independent Contractors and shall indemnify and hold harmless AACOG, AACOG staff and program clients from all claims arising out of work performed.
- 1.5.6** The Federal Privacy Act of 1974 and related State law and regulation regulate the proper disclosure of individually identifiable information and/or records. Contractors must take special precautions to protect confidential information from loss, authorized use, access, disclosure, modification and destruction.
- 1.5.7** The performance of this RFA and all work or obligations covered by and arising out of this RFA shall be at the risk of Contractor exclusively. To the fullest extent permitted by law, Contractor shall, with respect to all work or obligations covered by or arising out of the this RFA, or the performance thereof, indemnify, hold harmless and defend AACOG and each of its officers, partners, joint venture partners, representatives and/or employees from and against any and all allegations, losses, claims, actions, demands, damages, liabilities, or expenses (including costs, expenses and attorney's fees), arising directly or indirectly from this RFA, or the performance thereof.

- 2.3.4** During the period between the date AACOG issues this RFA and the date of the selection of the Contractors by AACOG, if any, Respondents shall restrict all contact with AACOG and direct all questions regarding this RFA, including questions regarding terms and conditions, only to



the individual identified above in Section “Inquiries and/or Discrepancies” in the specified manner. Do not contact members of the Board of Directors, other employees of AACOG or any of AACOG’s agents or administrators. Contact with any of these prohibited individuals after issuance of this RFA and before selection is made, may result in disqualification of the Respondent. The communications prohibition shall terminate when the contract is executed by the Contractor and AACOG.

**2.3.5** Prohibited communications include direct contact, discussion, or promotion of any Respondent’s Application with any member of AACOG’s Board of Directors or employees except for communications with AACOG’s designated representative as set forth in this RFA and only in the course of inquiries, briefings, interviews, or presentations. This prohibition is intended to create a level playing field for all potential Respondents, assure that decisions are made in public, and to protect the integrity of the RFA process. ## **2.5 PROPRIETARY INFORMATION AND THE PUBLIC INFORMATION ACT**

**2.5.1** Because contracts are awarded by a governmental entity, all responses submitted are subject to release as public information after contracts are executed. If a Respondent believes that its response, or parts of its response, may be exempted from disclosure, the Respondent must specify page-by-page and line-by-line the



parts of the response, which it believes, are exempt. In addition, the Respondent must specify which exception(s) are applicable and provide detailed reasons to substantiate the exception(s). Any information that is unmarked will be considered public information and released, if requested under the Public Information Act.

- 2.5.2** The determination of whether information is confidential and not subject to disclosure is the duty of the Texas Office of Attorney General (OAG). AACOG must provide the OAG sufficient information to render an opinion and therefore, vague and general claims to confidentiality by the Respondent are not acceptable. AACOG must comply with the opinions of the OAG. AACOG assumes no responsibility for asserting legal arguments on behalf of any Respondent. Respondents are advised to consult with their legal counsel concerning disclosure issues resulting from this procurement process and to take precautions to safeguard trade secrets and other proprietary information. After completion of the award, these documents will be available for public inspection.

### **PART 3.0—GENERAL INFORMATION & ADMINISTRATIVE REQUIREMENTS**

#### **3.1 ELIGIBLE PROVIDERS**

- 3.1.1** AACOG expects to receive Applications from multiple established and knowledgeable entities with demonstrable expertise in the tasks identified in the RFA. The proposers selected for contract award will be placed on a list of approved AACOG contractors and will be responsible for tasks outlined in the SOW.
- 3.1.1.1** Contractor Eligibility and Participation Requirements
- 3.1.1.2** Historically Underutilized Businesses (HUBs) Participation
- 3.1.1.2.1** It is the policy of AACOG to encourage the participation of small and Historically Underutilized Businesses (HUBs), as defined under Texas Government Code, Chapter 2161, in contracting opportunities. AACOG has established a goal of awarding at least ten percent (10%) of the total annual contract value to HUBs. Contractors are strongly encouraged to subcontract with or otherwise engage HUBs in the delivery of services under this RFA, where feasible.
- 3.1.1.3** To be eligible for consideration under this RFA, Applicants must meet the following minimum qualifications:
- 3.1.1.3.1** The Contractor must be licensed to do business in the State of Texas.
- 3.1.1.3.2** The Contractor must demonstrate a minimum of three (3) years of documented experience in the implementation of Energy Conservation Measures (ECMs).
- 3.1.1.3.3** The Contractor must possess Lead Safety Certification for both the applicant entity and all staff who will be assigned to perform services under this contract.
- 3.1.1.3.4** The Contractor must own and/or maintain all tools and equipment listed in Exhibit B – Tools and Equipment List, which is attached to and made a part of this RFA.
- 3.1.1.3.5** Contractor shall carry adequate comprehensive general liability insurance coverage, Pollution Occurrence Liability Insurance, and motor vehicle coverage for personal injury and for property damage for





purposes of protection against the hazards arising out of or in connection with carrying out any activities under this contract.

- 3.1.2** AACOG is prohibited from contracting with any entity debarred, suspended, or otherwise excluded from or ineligible for participation. Accordingly, a contract requires Contractors to certify that they are in compliance with the Federal regulations implementing Executive Order 12549, Debarment and Suspension, 29 CFR Part 98, Section 98-510, Participant's Responsibilities. The Contractor must certify that to the best of its knowledge and belief that neither it nor its principals or subcontractors are presently debarred, suspended, proposed for debarment, declared ineligible, or voluntarily excluded from participation in this transaction by a federal department or agency.
- 3.1.3** Respondents must possess the knowledge, experience and expertise, professional judgment and capacity within their organization to perform the services and activities requested under this RFA and meet high standards for public service and fiduciary responsibility.

## **3.2 CONTRACT INFORMATION**

- 3.2.1** TYPE OF APPLICATION: This Request for Application will result in an indefinite delivery / indefinite quantity (IDIQ), fixed price contract, determined by demand and based on the Weatherization Standard Price list. There will be no guarantee of work assigned or awarded.
- 3.2.2** CONTRACT PERIOD: It is anticipated that the initial contract period will be for three (3) years, with an option for two (2) or one (1) year extensions, mutually approved annually by the vendor and AACOG Board of Directors. The maximum number of consecutive years that a contractor may provide services will be five (5) years.
- 3.2.3** AACOG reserves the right to terminate a contract at any time based on Contractor performance or noncompliance.
- 3.2.4** ADDITIONAL FUNDING: AACOG reserves the right to expand the contract to include additional tasks in the Application response that AACOG deems beneficial to the area.
- 3.2.5** REASSIGNMENT: In the event a Contractor fails to perform as required, AACOG reserves the right to terminate the contract early and assign the contract in whole or in part to a comparably ranked proposer/Application obtained through this procurement, subject to successful contract negotiations.
- 3.2.6** Within 30 days written notice by either party if Contractor shall be required to satisfactorily complete all projects in progress at the time notice is given.
- 3.2.7** In the event of a breach of the terms of this RFA by either party hereto that is not remedied within five (5) working days after delivery of written notice of such breach, the non-breaching party may terminate this RFA by providing ten (10) Days written notice to the other party of their intent to terminate the contract.

## **3.3 GOVERNING PROVISIONS AND LIMITATIONS**

Violation of any of the following provisions may cause an application to be disqualified and rejected from consideration:

- 3.3.1** The Application, if accepted, will become the basis for the contract scope of work.
- 3.3.2** Respondents must submit a comprehensive Application for all services solicited. Any Application that is not comprehensive will be deemed non-responsive.



- 3.3.3** The only purpose of this RFA is to ensure uniform information in the solicitation of Application for the procurement of identified services. This RFA is not to be construed as a purchase agreement, contract or as a commitment of any kind; nor does it commit AACOG to pay for costs incurred prior to the execution of a formal contract unless such costs are specifically authorized in writing by AACOG.
- 3.3.4** AACOG reserves the right to accept or reject any or all Application received, to cancel or reissue this RFA in part, or its entirety.
- 3.3.5** AACOG reserves the right to award a contract(s) for any services solicited in this RFA in any quantity AACOG determines is in its best interests.
- 3.3.6** AACOG reserves the right to extend, shorten, increase, or decrease any contract awarded as a result of this RFA.
- 3.3.7** AACOG reserves the right to request additional information, clarification of or explanation for any aspect of a response to this RFA.
- 3.3.8** AACOG reserves the right to waive any minor defect in the procurement process or to correct any error(s) and/or make changes to this solicitation it deems necessary. AACOG will provide notifications of any changes in this RFA to all interested parties having requested or received a copy of this RFA.
- 3.3.9** AACOG reserves the right to negotiate the final terms of all contracts or agreements with selected Respondents and any such terms negotiated as a result of this RFA may be renegotiated and/or amended in order to successfully meet the needs of the regional area.
- 3.3.10** AACOG reserves the right to contact any individual, agency, employer, or granting agencies listed in an application, contact others who may have experience and/or knowledge of the respondent's relevant performance and/or qualifications; and to request additional information from all respondents.
- 3.3.11** AACOG reserves the right to conduct on-site reviews of records, systems, procedures, including credit and criminal background checks of any entity selected for funding under this RFA. This may occur either before or after the award of a contract or agreement. Any misrepresentation of the proposer's ability to perform as stated in the RFA response may result in the cancellation of any contract or agreement awarded.
- 3.3.12** AACOG reserves the right to withdraw or reduce the amount of an award or to cancel any contract or agreement resulting from this RFA if adequate funding is not received by AACOG from funding sources or due to legislative changes.
- 3.3.13** Respondents shall not, under penalty of law, offer or provide any gratuities, favors or anything of monetary value to any officer, board member, employee, Application evaluator, or agent of AACOG or elected official for purposes of having an influencing effect on this procurement.
- 3.3.14** Respondents shall not attempt in any manner to advocate for, lobby or otherwise attempt to influence any officer, board member, employee, Application evaluator, or agent of AACOG or elected official for purposes of having an influencing effect on this procurement.
- 3.3.15** No officer, board member, employee, Application evaluator, or agent of AACOG shall participate in the selection, award, or administration of a contract if a conflict of interest, or potential conflict, is involved.
- 3.3.16** Respondents shall not engage in any activity that will restrict or eliminate



competition. Violation of this provision will cause a respondent's Application to be disqualified and rejected. This does not preclude joint ventures or subcontracts.

- 3.3.17** The contents of a successful Application will become a contractual obligation if selected for the award of a contract. Failure of a respondent to accept this obligation may result in cancellation of an award. No plea of error or mistake shall be available to the successful proposer as a basis for release from proposed services at the stated price/cost. Any damages assessed by AACOG as a result of a successful proposer's failure to contract with AACOG may be recovered from the proposer.
- 3.3.18** A contract with a selected proposer may be withheld, at the sole discretion of AACOG, if issues of contract or questions of non-compliance, questioned/disallowed costs, audit/monitoring findings or legal issues exist, until such issues are satisfactorily resolved.
- 3.3.19** AACOG is exempt by law from paying State Sales Tax and Federal Excise Tax.
- 3.3.20** The contractor shall retain all records for a minimum period of seven (7) years after AACOG makes final payment and all other pending matters are closed. This requirement is to assure fair settlement of disputes or complaints that may arise, as well as to fulfill federal audit requirements.
- 3.3.21** **NON-DISCRIMINATION AND EQUAL EMPLOYMENT OPPORTUNITY:** Contractor provides its assurance that it will comply with all requirements of applicable Federal and State laws that no person providing or receiving services under this contract will be excluded from participation, or be otherwise subjected to discrimination because of race, color, religion, gender, sexual orientation, national origin, age, disability or political affiliation or belief.

**3.4 ADMINISTRATIVE REQUIREMENT AND LIMITATIONS.** Contractor will be required to procure all insurance required by this RFA and to list AACOG as an additional insured on each policy prior to the commencement of any work pursuant to a contract executed as a result of this RFA when applicable (or if funding becomes available). Liability coverage and deductibles must be acceptable to AACOG.

- 3.4.1** **INSURANCE REQUIREMENTS** - CONTRACTOR will be required to provide proof of general liability and casualty insurance coverage prior to contract execution:
  - 3.4.1.1** Performance bonding: \$10,000
  - 3.4.1.2** Pollution Occurrence Insurance: \$500,000 per occurrence
  - 3.4.1.3** General Liability: \$100,000
  - 3.4.1.4** Personal Injury: \$100,000
  - 3.4.1.5** Property damage: \$100,000
  - 3.4.1.6** Automobile Liability: \$500,000 per occurrence
- 3.4.2** Respondents must be able to demonstrate the necessary administrative and fiscal capability necessary to successfully provide required services and to meet the financial accountability requirements of federal grants when applicable (or if funding becomes available).
- 3.4.3** Contractors must provide reports upon demand as may be requested or required by AACOG.
- 3.4.4** Private for-profit corporations submitting an application must include a statement signed by an authorized representative of the corporation authorizing submission of an application.
- 3.4.5** AACOG shall require the Contractor to remove any employee or staff member from



the contract who is alleged (accused, arrested, or charged) to have committed a disqualifying offense after the background check performed. The contractor is required to immediately notify AACOG when it becomes aware of the alleged offense to determine if it disqualifies the employee or staff member from continuing to work under the contract.

- 3.4.6 Respondents must possess the knowledge, experience and expertise, professional judgment and capacity within their organization to perform the services and activities requested under this RFA.

## **PART 4.0 – PROPOSAL REVIEW AND SELECTION PROCESS**

### **4.1 EVALUATION PROCESS:** The evaluation process will consist of:

- 4.1.1 An initial review of responsiveness and eligibility with the criteria specified in the RFP by AACOG personnel.
- 4.1.2 All compliant applications will be evaluated and scored by an independent team of reviewers. The proposer's qualifications will be evaluated on specific criteria outlined in Section 4.2 by reviewers using a standardized scoring matrix.

### **4.2 EVALUATION CRITERIA:**

- 4.2.1 The Contractor must be licensed to do business in the State of Texas.
- 4.2.2 The Contractor must demonstrate a minimum of three (3) years of documented experience in the implementation of Energy Conservation Measures (ECMs).
- 4.2.3 The Contractor must possess Lead Safety Certification for both the applicant agency and all staff who will be assigned to perform services under this contract.
- 4.2.4 The Contractor must own and/or maintain all tools and equipment listed in Exhibit B – Tools and Equipment List, which is attached to and made a part of this RFA.
- 4.2.5 Contractor shall carry adequate insurance identified in Section 3.4.1, comprehensive general liability insurance coverage, Pollution Occurrence Liability Insurance and motor vehicle coverage for personal injury and for property damage for purposes of protection against the hazards arising out of or in connection with carrying out any activities under this contract.

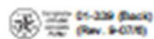

# Housing for Texas Heroes Grant Program

The Housing for Texas Heroes (H4TXH) Grant Program provides home modifications, repair, and weatherization for veterans and surviving spouses who live in Texas.

## Eligible Beneficiaries: Very Low and/or Low-Income Veterans, Surviving Spouses

1. Clients must be Very Low or Low-Income.
  - Very Low-Income Household (50% of the median family income for the county in which the beneficiary resides per HUD)
  - Low-Income Household (80% of the median family income for the county in which the beneficiary resides per HUD)
2. Clients who meet income requirements and are determined a disabled veteran by the VA are the highest priority for services and wait lists.
3. Clients must be listed on file with the county appraisal district as the current owner(s) of the property.
4. Clients must be current on existing mortgage loans or home equity loans.
5. Clients must be current on property taxes or deferred by the county appraisal district.
6. Property receiving services must be the client's primary residence and located in Texas.

## Eligible Services:

1. **Home modification projects** to improve accessibility that support living in a home based on physical disabilities or handicaps (accessibility modifications to walkways, doors, kitchen, and bathroom). Home modification projects must assist the VA disability or handicap.
2. **Home repair projects** to correct dangerous housing conditions to make home safe (plumbing, electrical, walls, flooring,). Home repair projects must correct dangerous and life threatening conditions and not repair wanted upgrades to improve the aesthetic of the home.
3. **Home weatherization projects** to correct elements (wind and water) from entering the home (sealing of doors & windows, siding, roofing). Weatherization projects for energy efficiency upgrades or repairs are not allowed, Federal and other State programs provide such services.

**The maximum amount H4TXH funding for Project for each veteran household is \$35,000 per grant period.**

### **Verify Current Ownership & Residence**

Before committing to or beginning the project, verify the beneficiary (veteran or surviving spouse):

1. Is listed as the 100% owner via the County Tax Appraisal District's office; AND
2. Homestead - Lives in it as a primary residence

### **County Tax Appraisal District Verification**

The beneficiary must be listed as the 100% owner on official County property tax records. Examples of acceptable proof include:

- Warranty Deed
- Special Warranty Deed
- Irrevocable Trust where veteran (or surviving spouse) is listed as the beneficiary of the trust

Grantees carry the burden of substantiating ownership of the property. If clear, absolute evidence of beneficiary ownership is not provided to TVC at time of reimbursement, the Grantee may be liable for covering the costs of the project.

### **Current on Loans & Property Taxes**

Ensure beneficiaries are CURRENT on all of the following before committing to or beginning the beneficiary project:

- Mortgage loans
- Home equity loans; AND
- Property taxes

### **Exceptions And Prior Approvals**

If criteria outlined above cannot be met, contact your Grant Officer to discuss an exception.

### **Reporting Tools**

The following items will help your organization collect the required information needed to request reimbursement.

#### **Project Checklist**

- Use the Project Checklist to guide planning, eligibility confirmation, and document gathering to support reimbursement.

#### **Project Form**

- Complete the Project Form to support reimbursement.

#### **Before & After Photos**

- Review the Before and After Photo guidelines in this document on page 8, to ensure that adequate photo documentation is captured before and after. Photo documentation is required for reimbursement.

# Housing for Texas Heroes Grant Project Checklist

Organization must retain the following documentation for all Projects completed. Do not submit these documents to FVA when requesting reimbursement for completed Projects.

This documentation should be readily available for review by FVA during a compliance or technical visit, desk audit, or upon request at any point in the applicable retention period, to ensure adherence to FVA grant eligibility and compliance requirements. Organizations must retain all records pertaining to the grant for 3 years (per TxGMS guidance) or by the organization's policy requirements, whichever is longer.

- ☐ **Proof of Veteran Status Including Character of Service**  
Must coincide with permitted TVC documentation for Veteran/Surviving Spouse Beneficiary eligibility.
- ☐ **Proof of Very Low-Income or Low-Income Status**  
Verify income on pay stubs, and/or SSI payments to determine income in comparison to AMI for Texas county according to HUD.
- ☐ **If Claiming Disabled Status**  
Veteran or surviving spouse must first qualify by being low or very low income, then verify VA Disability Letter for placing them as priority among waitlists.
- ☐ **Proof of Home Ownership**  
Verify the Beneficiary is the owner of the home as reflected in a warranty deed, special warranty deed, or listed as the Beneficiary of the trust that is listed as the owner with county tax records.
- ☐ **Proof of Homestead**  
Verify home is primary residence receiving Project services.
- ☐ **County Tax Statement & Mortgage Loan Statement**  
Demonstrating Beneficiary is current on property taxes (or current on tax deferral payment plan), and any form of home loan.
- ☐ **Bid Solicitations**  
Must demonstrate the method and process for contractor/vendor selection for labor and materials. All projects over \$10,000 must follow federal and state contracting requirements.
- ☐ **Inspection Reports**  
Demonstrating pre-inspection, final inspection, and any instance during the Project.
- ☐ **Fully Executed Contract to Provide Services on Statement/Scope of Work (SOW)**  
Must be signed by Grantee and Contractor; and coverage dates must occur within the active grant period to be considered valid and fully executed.
- ☐ **Statement/Scope of Work (SOW)**  
The detailed description of what repairs or modifications are expected to be completed during the project. # Housing For Texas Heroes Grant Project Before & After Photo Requirements

Housing for Texas Heroes project reimbursement requests must include a picture depicting the front face of the home, as well as pictures illustrating all individual areas of the project scope before and after completion.

Pictures illustrating the completed project help TVC's grant officers ensure transparency in reporting, as well as help the grantee justify costs reported for reimbursement. Pictures of each job component of Housing for Texas Heroes projects must be included in the supporting documents submitted with the reimbursement request. Reimbursement requests will be delayed until grantee provides required pictures.

## **Minimum Requirements**

- Pictures must be taken by a designated grantee representative.
- Include (1) picture of the front façade of the home owned by the veteran or surviving spouse
- Include at least (1) before picture next to (1) after picture of each individual job area making up the total home modification, repair or weatherization project

## **Format Guidelines**

- Must be in color (no black and white scans)
- Must illustrate the exact location of job component within the interior or exterior of the home
- Before and After images must be adjacent to each other in the support document PDF
  - o *(see examples in this section)*
- Before and After images must be taken from the same angle

- Maximum of 4 images per page

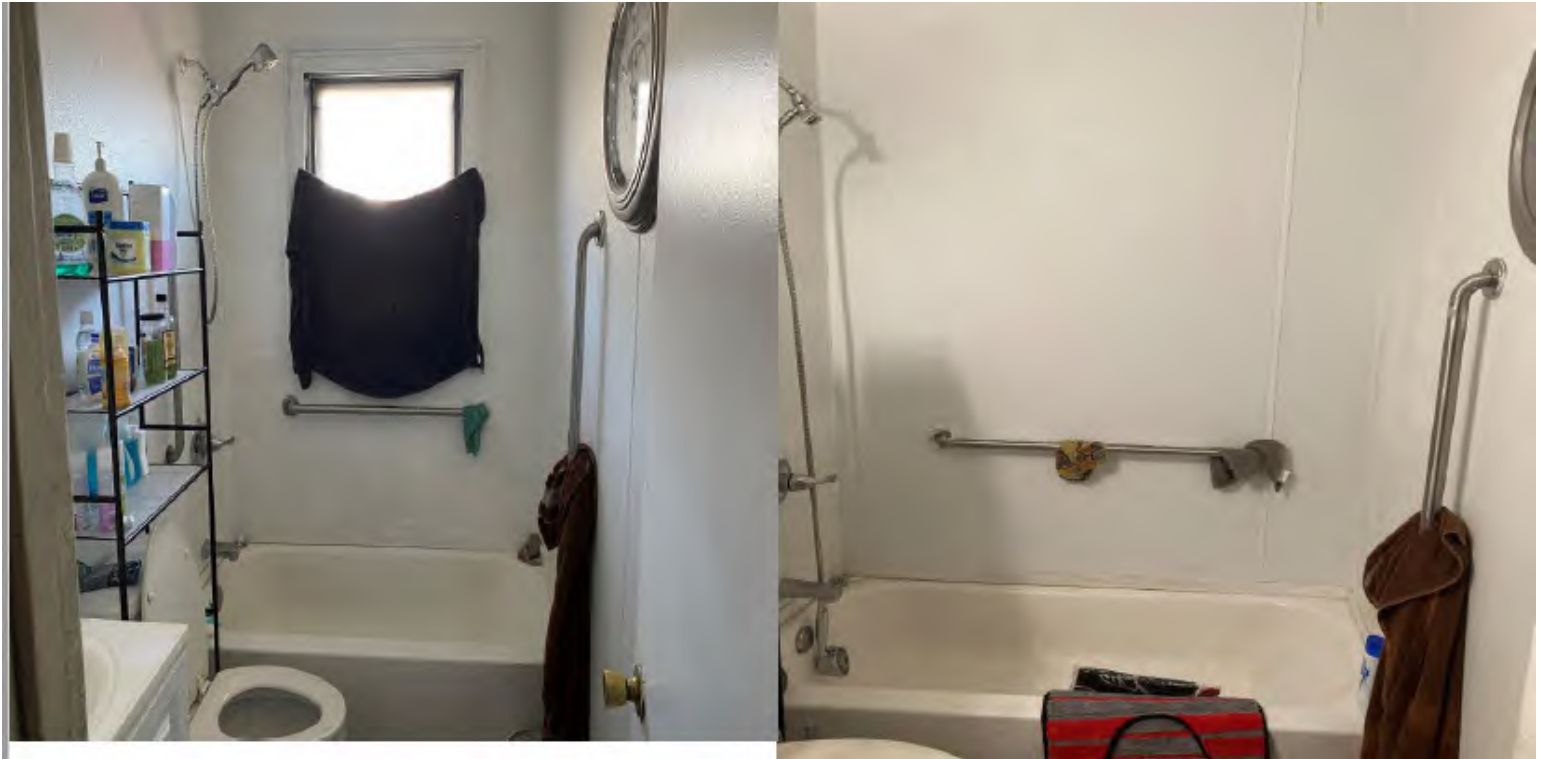

# Housing For Texas Heroes Project Examples

## Examples of Allowable Exterior Items

1. Driveway: repair or leveling for accessibility or ease of walking for elderly.
2. Sidewalk: repair or leveling for accessibility or ease of walking for elderly.
3. Roof: repair or replacement.
4. Foundation: leveling or repair.
5. Rodent infestation: repair to exterior of home to prevent rodents from entering subflooring or attic.
6. Caulking: caulking of exterior of home to prevent weather and element from entering.
7. Siding: repair or replacement to prevent weather elements from entering the house.
8. Painting exterior: painting of weather damaged siding and home exterior to extend life.
9. Ramp: install or repair for entry into all exits of home for accessibility or ease of walking for elderly.
10. Deck: repair or replace for accessibility or ease of walking for elderly.
11. Fence: for service animal, install, repair, replace.
12. Lawn: drainage and leveling to prevent water from entering the home.
13. Surface drain: for foundation to prevent water from entering the home.
14. Electrical Drop and meter enclosure repair or replacement to meet code.
15. Light fixtures: repair of existing light fixture or replacement with comparable fixture.
16. Plumbing exterior: repair or replace water pipes and fixtures to prevent leaks of fresh water.
17. Plumbing exterior: repair or replacement of sewage pipes to ensure proper elimination of waste.
18. Septic system: repair or replacement to prevent leaks and ensure proper elimination of waste.
19. HVAC system: repair or replacement of air conditioner, coolant, refrigeration lines, furnace, air handler, indoor coil, register, supply air duct, return duct and thermostat.
20. Window: replacement or repair due to broken glass or frame to prevent weather elements from entering home.
21. Door and frame exterior: repair or replacement to secure home and prevent weather elements for entering home.
22. Tree removal: removal of tree or tree limbs overhanging above home to prevent future damage.

*Please reach out to your grant officer to request guidance if your Project type is not listed as an example.*

## **Examples of Allowable Interior Items**

1. Doorway widening of exterior doors or interior doors to allow accessibility for wheelchair.
2. Subfloor: leveling and repair for habitability, accessibility, or ease of walking for elderly.
3. Carpet replacement: replacement of old, worn carpet or carpet that prevents accessibility or ease of walking for elderly.
4. Flooring: repair or replacement for accessibility or ease of walking for elderly.
5. Ceiling: repair or replacement due to water or weather damage.
6. Walls: repair or replacement due to water or weather damage.
7. Painting: painting of interior of home to extend life of weathered materials, to cover repaired area, and cover water damage areas that do not need replacement.
8. Electrical: circuit breakers and panel, repair, or replacement to ensure home is to code.
9. Electrical: replacement of non-operational outlets, light switches and covers.
10. Electrical wiring: replacement and repair of home wiring to ensure home is to code.
11. Light fixtures: repair of existing light fixture or replacement with comparable fixture.
12. Ceiling Fan: repair non-operational fan or replacement with comparable model.
13. Plumbing interior: repair of water pipes and fixtures to prevent leaks.
14. Plumbing interior: replacement of water pipes to ensure home is to code.
15. Plumbing interior: replacement of unrepairable water fixture with comparable model.
16. Refrigerator: repair or preplace with comparable model.
17. Stove: repair or replace with comparable model.
18. Microwave: repair or replace with comparable model.

### **Examples of Allowable Bathroom Project Items**

1. Remodel for Americans with Disabilities Act (ADA) compliance and accessibility.
2. Door, widen entrance and replace door and door frame for wheelchair accessibility.
3. Vanity and sink: Position lower on wall for wheelchair accessibility; includes required plumbing and fixture.
4. Toilet: replace with ADA-compliant model.
5. Bath: install ADA-compliant walk-in shower or ADA-compliant tub for accessibility along with required plumbing and fixtures.
6. Grab bars: install bars as required for toilet and bath.

### **Examples of Allowable Kitchen Project Items**

1. Remodel for ADA compliance & accessibility.
2. Door: widen entrance and replace door and door frame, for wheelchair accessibility.
3. Counter tops: lower height for ADA compliance and wheelchair accessibility.
4. Sink: lower height for wheelchair accessibility; includes required plumbing and fixture.
5. Upper cabinets: position lower on wall, for wheelchair accessibility.
6. Lower cabinets: replace lower cabinets to reduce height, for wheelchair accessibility.
7. Stove: replace with ADA-compliant model.
8. Refrigerator: replace with ADA-compliant mode.

### **Unallowable Items**

1. New additions to the property are not allowed.
2. Modifications, Weatherization, or Repairs to non-primary residential home or structure
3. Window upgrade for energy efficiency
4. Energy efficiency repairs or modifications to reduce electrical cost
5. Gutter installation
6. Kitchen/ bathroom remodels for aesthetic purposes
7. Carpet replacement for wood flooring for aesthetic purposes
8. Painting exterior or interior for aesthetic purposes
9. Installing deck/ landings without medical necessity
10. Fence repair or replacement, UNLESS for service animal (see Allowable exterior items)
11. Landscaping or Yard Clean-up

Discuss any special needs you may need to complete this project. Please ask the homeowner if they have any special needs and or concerns about this project. AACOG will send the Notice To Proceed, to start the project.

Possible issues to discuss:

1. Where do your workers park?
2. Where is material to be delivered?
3. What time is work to begin and end and on what days?
4. What about small children?
5. What about pets?
6. What about bathroom accommodations?

*Please leave an emergency contact phone number with the homeowner in case something was overlooked during the day and homeowner needs to contact you after work hours.*

Please clean the work area at the end of each work day. Dispose of all trash and debris. Make sure that when you leave for the day that the homeowner has access to the plumbing fixtures. Make sure that any utilities that were turned off earlier in the day are functional prior to your departure.

All of the materials that are required for this project have particular model specifications. Any deviation from the list of allowable material will result in non-payment. Variation from the attached specifications is not encouraged; if there is no other option available then all changes in materials must be approved by AACOG staff in writing. You will be assigned an AACOG inspector for your project. If the project is located in a building jurisdiction that has an ongoing building permit and inspection program, then you will be required to obtain all necessary building permits and inspections. If the project is in a rural area without an ongoing inspection program then the AACOG Inspector will perform the required inspections. Do not cover any inaccessible area until the appropriate inspections are obtained. Contact the AACOG Inspector for required inspections

Please follow the EPA Repair, Remodeling and Painting Rule (RRP), which went into effect on April 22, 2010. <http://www.epa.gov/lead/pubs/renovation.htm> . All contractors that disturb a painted surface in any pre-1978 house and are compensated must be registered with the EPA as a Lead Renovator Firm. Additionally, each certified renovator firm must have at least one employee certified with the EPA as Lead Certified Renovator. The EPA documentation for your firm must be on file at AACOG prior to beginning any work. At the end of each project that consists of a pre-1978 house you will be asked to submit the following documentation:

1. Any Lead Base Paint (LBP) test results with all appropriate EPA required documentation.
2. The renovator recordkeeping checklist
3. The post renovation cleaning verification report
4. The non-certified worker training documentation
5. Signed receipt by homeowner regarding delivery of the "EPA Renovate Right" pamphlet, which can be obtained at 1-800-424-5323.

Do not wait until the end of the job and to produce these documents. They are intended to be produced at the beginning of the job and continue as the job progresses. These documents record the lead-based paint safe worker practices your firm employs to protect the health and safety of your employees as well as the occupants of the house. As of August 2016 EPA, is assessing a \$40,000.00 a day penalty for contractor non-compliance.
